## TOURNAMENT RULES AND REGULATIONS

Read These Rules and Regulations Carefully – Failure to Read is No EXCUSE ENTRY DEADLINE: ENTRIES close midnight, Wednesday, DECEMBER 04, 2024

- OPEN TO ALL TNBA/USBC members, at least 18 years of age (by August 1, 2024) and will be operated under the tournament rules of TNBA, and USBC. Any entrant who cannot present his /her USBC or TNBA membership card prior to bowling, will be required to purchase the necessary membership card on site. No membership application stubs will be accepted. TNBA membership cards may be purchased at a cost of \$30.00 each. USBC Associate cards may be purchasedat a cost of \$30.00 men and women. If the membership cards are shown prior to the end of the bowlers' participation in the tournament that same day, full refunds will be made. Any entrant not adhering to the above rule will not be allowed to bowl in the tournament.
- 2. The Tournament will consist of MIXED Teams and MIXED Doubles events. Teams on Saturday and Doubles on Sunday. Optional singles while bowling doubles. Separate singles division for women and men. Men cannot enter the women's singles, and the women cannot enter the men's singles. If you are bowling on more than one team, please send all entries in together.
- USBC RULE 310a WILL APPLY. "No late entries will be accepted." The Tournament Directors and/or Committee reserve the right to reject any entry for any reason and return any entry fee. Additional squads may be added to the tournament prior to the last squad.
- 4. Fees in the form of MONEY ORDERS, BANK CHECKS or CERTIFIED CHECKS must accompany the application form.
- 5. Social Security numbers will be required for all bowlers who WIN \$600.00 OR MORE, prior to our mailing out your check. (NO NICKNAMES) INDIVIDUAL ADDRESSES FOR ALL BOWLERS are REQUIRED.
- 6. Multiple Entries Permitted. However, you may cash only once with the same partner/s. Not more than two (2) bowlers on the same team may re-enter on an additional team. Two bowlers will need to be replaced. Teams will consist of (4) bowlers of any mixture of men/women combinations. Doubles will consist of (1) one male and (1) one female. Bowlers may CASH only ONCE with the same partner. Bowlers may PLACE only ONCE in the optional singles event. Any bowler that has held a PBA/PWBA membership card, cashed, or participated in a PBA/PWBA sponsored event within the past five years will not be allowed to bowl in this tournament. A bowler may only bowl on one entry per squad.
- 7. Entrants must use their highest USBC (Bowl.com) average based on a minimum of (42) games for the 2023-2024 seasons. NO SUMMER OR STRING BOWLING LEAGUE AVERAGES MAY BE USED. All SPORT and CHALLENGE league averages must be converted to a Standard Average as per the appropriate USBC Conversion chart to be used in this tournament. All others must use their HIGHEST CURRENT CERTIFIED AVERAGE at the time of bowling, based on a minimum of 42 games. A League Standing sheet signed by the League secretary is required. If none of the above, the bowler must enter with a 220 average.

- USBC Rule 319a., 1-4 will apply, Rule 319b, the 10 Pin rule will apply. USBC Rule 319c., Rule 319d and USBC Rule 319e will apply. Average adjustment will apply. (If an entrant has been re-rated before, they must report their re-rated average, even if the entrant did not accept the adjusted average.)
- 8. If an entrant submits an average less than his/her true average he/she will be disqualified and shall forfeit all prize money.
- Handicap will be 90% of 220 for both men and women.
   The handicap will be figured individually for each bowler.
- 10. Replacements will be permitted, and the bowler must bowl in the position of the original entrant. All rules and regulations herein will also apply to the replacements.
- 11. The Tournament Committee reserves the right to disqualify any entrant not in compliance with the rules of the tournament, TNBA and USBC. Premature termination of the tournament brought about by war, national emergency or emergency causes relating to or from, fire natural disaster or any other reason beyond the control of the TNBA Savannah Senate will result in all prizes being prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.
- 12. Team Captain must report to the tournament office at least one hour before time scheduled to bowl and present their TNBA, USBC cards for each team member. All changes are to be made one hour prior to squad time.
- 13. Events will be bowled in the order names are listed on the entry form. No changes in the submitted lineup will be made.
- 14. Team Captains and/or Coordinators will be notified of the day and times assigned to bowl. Tournament management reserves the right to add or delete any squad due to the number of entries. The Tournament Committee's squad schedule will be final. No lane changes will be permitted.
- 15. Errors in scoring must be reported to the Tournament Director's office within 24 hours after the games are bowled.
- 16. Tardy players will start in frames being bowled with zero being given for each frame missed. If a team refuses to start because a full line-up is not present, they will forfeit all games which they decline to bowl. No blind score will be permitted, and a bowler must bowl with and on the same lanes and at the same time as his/her team bowls.
- 17. No refunds will be made once an entry has been received, processed and confirmation provided to the applicant.
- 18. Prize funds will be returned 100% to each event, Team, Doubles and Singles. The payout ratio will be at least 1:10 in each event including the optional Singles for Men and Women.
- 19. Any rule not covered here will be governed by the rules of USRC
- The Tournament reserves the right to disqualify any entrant not in compliance with the rules of the tournament, TNBA and USBC.
